The remuneration of empanelled Part-time teachers will be as under:


- (i) For eligible candidates having NET/Ph.D. will be paid @ 750/- per lecture to a maximum of Rs. 34,000/- per month.  
(ii) For non-NET/Ph.D. candidates will be paid @ Rs. 500/- per lecture to a maximum of Rs. 25,000/- per month.


